

RESOLUTION NO. 18-VAB-1
A RESOLUTION OF THE VALUE ADJUSTMENT BOARD OF MARION COUNTY
FLORIDA, ADOPTING FINAL DECISIONS, PROVIDING FOR CERTIFICATION BY THE CHAIRMAN OF THE
VALUE ADJUSTMENT BOARD ON BEHALF OF THE BOARD,
AND PUBLICATION OF NOTICE OF TAX IMPACT

WHEREAS, the Marion County Value Adjustment Board is required to produce a written Final Decision that contains findings of fact, conclusions of law and reasons for upholding or overturning the property appraiser's determination as to all petitions not withdrawn or settled that are filed with the Board; and

WHEREAS, the Marion County Value Adjustment Board is required to certify an assessment roll after all hearings have been held and make certain certifications pursuant to Department of Revenue Rules as to the Value Adjustment Board process, the final assessment roll and the extended roll; and

WHEREAS, the Clerk of the Value Adjustment Board is required to publish a public notice advising all taxpayers of the findings and results of the Board's decisions;

NOW, THEREFORE, BE IT RESOLVED by the 2017 Value Adjustment Board of Marion County, Florida that:

SECTION 1: FINAL DECISIONS. Attached to this Resolution is a copy of the Final Decisions Adopted by this 2017 Value Adjustment Board. The Chairman of the 2018 Value Adjustment Board is authorized to execute and the Clerk of the Value Adjustment Board is directed to inform petitioners of the Final Decisions as Adopted by the Board.

SECTION 2: CERTIFICATIONS. The Chairman of the 2018 Value Adjustment Board is authorized to execute on behalf of the Board the necessary Certifications of the 2017 Value Adjustment Board required by Sections 193.122, 194.037, 193.1142 Florida Statutes, Rule 12D-9.037, Florida Administrative Code, and any other Statute or Rule.

SECTION 3: TAX IMPACT NOTICE. The Clerk of the Value Adjustment Board is directed to publish the Tax Impact Notice and the payment for the publication of the same is approved.

SECTION 3: EFFECTIVE DATE. This Resolution shall take effect immediately upon adoption.
