

RESOLUTION NO. 18-VAB-3

**A RESOLUTION OF THE VALUE ADJUSTMENT BOARD OF MARION COUNTY
FLORIDA, RATIFYING PAYMENTS MADE AND ACTIONS TAKEN UNDER RESOLUTION 18-VAB-2
AND PROVIDING FOR A PAYMENT OF INTERIM COSTS AND EXPENSES
UPON APPROVAL BY THE CHAIRMAN OF THE VALUE ADJUSTMENT BOARD**

WHEREAS, the 2017 Marion County Value Adjustment Board adopted Resolution No. 17-VAB-2 providing for the organizing and planning of the 2018 Marion County Value Adjustment Board and payment for the interim expense of the 2018 Marion County Value Adjustment Board; and

WHEREAS, Section 194.035, Florida Statutes, requires the Marion County Value Adjustment Board to appoint Special Magistrates and pay the compensation of those Special Magistrates as well as any expenses of hearings held by the Special Magistrates; and

WHEREAS, Section 194.035, Florida Statutes, authorizes the Marion County Value Adjustment Board, if necessary, to employ qualified property appraisers or evaluators to appear before the Marion County Value Adjustment Board; and

WHEREAS, Section 194.015, Florida Statutes, requires the Marion County Value Adjustment Board to appoint private counsel and to pay private counsel; and

WHEREAS, there is from time to time a need to make interim payment of expenses and/or compensation to the 2018 Marion County Value Adjustment Board's appointees and employees.

NOW, THEREFORE, BE IT RESOLVED by the 2018 Value Adjustment Board of Marion County, Florida that:

SECTION 1: RATIFICATION. The 2018 Value Adjustment Board of Marion County, Florida hereby ratifies and adopts Resolution No. 18-VAB-2 to the extent it applies to the 2018 Value Adjustment Board of Marion County, Florida, and approves the actions taken thereunder.

SECTION 2: COMPENSATION. The Chair or Vice Chair of the 2018 Marion County Value Adjustment Board is authorized to approve interim payments to its Counsel; Special Magistrates; property evaluators and any other authorized personnel who are employed by the 2018 Value Adjustment Board.

SECTION 3: COSTS. The Chair or Vice Chair of the 2018 Marion County Value Adjustment Board is authorized to approve interim payments for costs and expenses of the Board.

SECTION 4: EFFECTIVE DATE. This Resolution shall take effect immediately upon adoption.


