**ORDER GRANTING MOTION TO DETERMINE**  
**CONFIDENTIALITY OF COURT RECORDS**

THIS MATTER having come before the Court without the necessity of a hearing on the Guardian Ad Litem's Motion to Determine Confidentiality of Court Records, and the Petitioner being represented by Craig W. Turner, and the Respondent being represented by Anne E. Raduns, and the Court being otherwise fully advised in the premise, find as follows:

- A. This Court has jurisdiction over the parties, the child and subject matter hereto.
- B. On April 16, 2020 an Order Appointing Guardian Ad Litem ("Order") was entered by the Court.
- C. The Order required the Guardian Ad Litem to file a report and recommendation relative to the minor child subject to this proceeding, to wit: CBW born 2007.
- D. The Report of Guardian Ad Litem was filed on January 3, 2020.
- E. The Motion to Determine Confidentiality of Court Records was filed on January 4, 2021.
- F. The Report of Guardian Ad Litem contains confidential and sensitive information relative to the parties and their minor child.

G. It is not in the best interest of the child for the information to be made available to the public.

H. Craig W. Turner, Attorney for the Petitioner and Anne E. Raduns, Attorney for the Respondent have no objection to the Court being deemed as confidential. The parties agreed that the Guardian Ad Litem would provide a copy of the report to the Mediator for use at the mediation conference held on January 5, 2021.

Therefore, it is

**ORDERED AND ADJUDGED** as follows:

1. The Report of Guardian Ad Litem filed on January 3, 2021 is hereby deemed confidential and the Clerk is hereby directed to seal the same.
